Conclave Code of Conduct

The general welfare of any group depends upon the conduct of each individual member of that group. As an Arrowman, I understand this and on my honor, I pledge the following:

1. I will observe the Scout Oath, the Scout Law, and the OA Obligation as the Law of the Section W-4B Conclave.

2. I will wear a complete Scout or Explorer uniform at all times when appropriate, I will wear an OA sash only with my uniform or when in Native American attire.

3. I will attend all general sessions and assemblies called by the Section or Lodge.

4. I understand that certain items may not be purchased, possessed, or used at the Conclave or on site. These include alcoholic beverages, illegal narcotics, firearms, explosives, ammunition, or knives with a blade of over three and three-quarter inches. I will refrain from gambling and use of any foul language during the Conclave.

5. I will refrain from smoking if I am under 18 years of age and if over 18, will smoke only in designated areas.

6. I will not leave the Conclave site or enter a restricted area without the permission of my Lodge Advisor or the Section Advisor.

7. I will confine all trading/swapping to appropriate locations during free periods. I will also refrain from selling anything at the Conclave without permission from the Section.

8. I will observe a quiet period from taps to reveille.

9. I understand that speed limits and traffic rules are strictly enforced for everyone's safety. I will park only in designated areas and will refrain from using a vehicle during the Conclave unless issued a driving/parking pass.

10. I will refrain from using any open flames anywhere on or near the site without the permission of the camp ranger.

11. I will at all times be a considerate guest of our host, Orange County Council, Schoepe Scout Reservation.

I have read the above 2004 W4B Conclave Code of Conduct and on my honor as a Scout/Scouter, will abide by the Code.

II. Facilities and Administration

Section W4B, Conclave Plan Book, 2004 I. Facilities

Parking

We will be using two main parking lots at Schoepe Scout Reservation. The first will be at the Grace Gate entrance, behind Beckman Hall. The second will be the parking lot at the end of the main road into the valley, at the main entrance. We will try to fill up the parking lot behind Beckman hall first and then proceed to fill the main parking lot at the entrance. Should we need more parking, although not likely, we will park cars with the direction of the Ranger and Camp master Staff. The parking lot on the side of Beckman Hall will be used for Staff, disabled, and other persons requiring special needs. CARS WILL NOT BE ALLOWED TO PARK INSIDE CAMPSITES. The small parking lots across from Grace Pool and Grace Staff City are for LOADING/UNLOADING ONLY. Some primary staff will be allowed to park there along with disabled persons. If you feel you need a permit to park in one of these areas, please obtain a permit from the Administration office (located in Beckman Hall) when you check in. Campsite access will be granted for vehicles needing to load/unload, but ALL VEHICLES MUST PARK PROPERLY BY 10PM, FRIDAY NIGHT! For information on RV parking, please contact Deanna Westmyer (information on Front Page). Anyone without a valid permit after 10PM Friday will be asked to move their car. Remember the Speed limit in camp is TEN MILES AN HOUR in most places.

Meals

All meals will be prepared in Beckman Hall by the camps's food service and served inside the hall. Shifts are required for some meals. Check the conclave schedule for shift information.

Friday night we will have a full cracker barrel and Saturday we will hold an Ice-Cream social during the patch auction. Saturday lunch will also be sack lunches passed out at various locations.

Sanitation

Toilets are located inside each of the campsites, Beckman Hall, Wiatava Lodge, the Poolhouse and Staff City. Showers are located at the Poolhouse. These bathrooms correspond with Youth Protection Guidelines.

Theme

The Section Council of Chiefs, the section governing body of youth officers, representing all of the lodges in the section selected the following as the theme for the 2004 Conclave:

"Keeping the Traditions of the Honored"

Location

Navajo Lodge will be serving as the host council for the 2004 Section W-4B Conclave. They have arranged Schoepe Scout Reservation of the Orange County Council to serve as grounds for the event. A map of the camp is located within the plan book.

Participant Guide

Each Conclave participant will be supplied with a participation booklet, containing the schedule, event locations, code of conduct, dress code, meal schedule, map, etc. It is vital that all Arrowmen keep this passport in their possession at all times during their stay at Conclave. This participation booklet will also contain the requirements for the participation award, which should be completed while at camp.

Religious Services

On Sunday morning before breakfast there will be a non-Denominational (Scouts Own) service in front of Beckman Hall (Flagpoles).

First Aid

All injuries at the Conclave, no matter how minor, should be reported immediately to the EMT on duty, at the Health Lodge located in Central, across the meadow from Beckman Hall. A first Aid emergency vehicle will be standing by at the Health Lodge to take more serious cases to the hospital.

In case of an emergency contact the Business Office at Schoepe Scout Reservation at -----and leave a message specifying whom you need to speak to, their lodge, and the number for them to call. In the event, there is an emergency at camp, the family of the injured person(s) will be notified immediately. <u>All participants and required to have a permission slip, medical release, or</u> trip ticket with medical information, (allergies, etc), on file with the section and their lodge.

Safety is everyone's responsibility. Please be aware of what you are doing and report any unsafe situations that are discovered to the Conclave Committee. Everyone can avoid accidents with the use of a little common sense. BSA policy will be enforced.

Special Arrangements

If your lodge will require disability access, special assistance or arrangements during the Conclave, that are not covered in the guide, please contact the host lodge chairman (CVC of Site

Coordination) or adviser in advance of the event. Your specific needs can be address as long as the host lodge is made aware of your needs in advance.

Conclave Headquarters

Conclave Headquarters will be located in Beckman Hall. Please relay any questions or concerns to the headquarters.

Communications

The communications headquarters will be located adjacent to the Conclave headquarters inside Beckman Hall. At various times throughout the Conclave, the Bear Facts will be distributed to keep participants informed about what is going on.

Trading Post

There will be two trading posts at Conclave. The trading post will be selling refreshments and memorabilia. Pre-approved lodge items will be sold on consignment with a 15% commission fee to the Section. Contact the Section Advisor for imformation regarding selling those items. The Lost Valley Grace Trading Post will remain open for most of the event, but the Irvine trading post may open for a short while during the show. Hours for the trading post are as follows:

Tobacco

As of 1996, the BSA policy on the use of tobacco is as follows: "Adult leaders should support the attitude that young adults are better off without tobacco and may not allow the use of tobacco products at any BSA activity involving young participants." Use by adults in camp is highly restricted to areas where Scouts will not see the use at any time. Please notify your guests of this policy.

Check Out

After the closing ceremony on Sunday, each Lodge will be asked to work together to clean up certain areas that were utilized during the course of the Conclave. Lodge responsibilities will be distributed out at the Saturday night Council of Chiefs Meeting. Immediately following this time the Lodges will assist in cleaning up their respective campsites.

All participants will be required to check out individually with their lodge contingent leader. More information is located under Registration.

Section Elections

The sections elections this year will be held on Sunday at the closing ceremony. Each scout that wish's to run for a section officer position must have a sign letter from the council scout executive or there designee. The nominations for the Section Chief position will close at the Friday night COC Meeting, due to the Saturday morning training session requirement. The positions that are open are as follows: Section Chief, Section Vice Chief and Section Secretary. Each Lodge will get 10 votes to vote for each position. The votes can be spilt or as a whole it's all up to the lodge.

Conclave Dress Code

Al all times during the Conclave, participants should be encouraged to wear the field uniform. During some parts of the Conclave, participants are permitted to wear their activities uniform. These occasions include sports and ceremony events, lunch, and free time. Keep in mind however, that during assemblies, breakfast, dinner, training, religious services, and for all show, Arrowmen must be in their field uniform. If not, he or she will be asked to go back to camp and return with the necessary articles.

Training

Special time has been devoted to training at the conclave. No other schedules events will take place during the training portion of conclave. All courses are available online or can be found in the training portion of this book. In the event that you do not get the chance to register for a class, you may attend any class of your choice. Please be aware that many of the classes will fill to their maximum capacity, so it behooves you to pre-register. Registration can be done at anytime prior to 8:00 a.m. Saturday inside the Administration Office.

All information provided by means of your online registration will remain private and privileged to only adult advisors affiliated with the Section Council of Chiefs. Lastly, by submitting your registration information you agree to receive required administrative and promotional information electronically.

Welcome To Conclave Registration!

Online registration is an easy-to-use, web-based, integrated system for registering Arrowmen for Conclave 2004. This hassle free process has been made solely for individuals to "mark their intent" to attend Conclave 2004. All fees associated with the event will be collected at a later date and we do not ask for any form of payment during this online registration process; however, please note that your lodge will automatically be charged and will pay for your conclave fee once you submit your online registration. All forms of payment should go through your chapter or lodge representative at your earliest convenience; the collection of conference fees will be the responsibility of the lodge you are affiliated with; and its professionals. Members not affiliated with any of the lodges within Section W-4B can pay at the door; however, must register before the deadline to qualify for the early registration fee.

The conference fees are as follows: \$36.00 dollars for early registration and \$46.00 dollars for general registration. There will not be a spilt fee for youth and adults this year and unfortunately we will not be offering the first time participant fee. To qualify for early registration you must submit your online registration form to the section prior to April 1, 2004; all online registration forms submitted and received after April 1, 2004 will be charged the general conference fee of \$46.00. This year the section is requiring *all* individuals who will be attending conclave to register online or they will be subject to the general fee of \$46.00 dollars; the same applies to walk-ins at conclave. Registration will remain open until the Thursday night before Conclave and we will still require participants to register after the April 1, 2004 deadline has passed. Please note that if you register after the deadline you must bring your conclave fee with you to the event. There will not be any mail in registration this year!

Please be prepared by having all your personal and emergency contact information ready and available prior to beginning the online registration process. This must be on file and available to the conference management so that in the event of an emergency the proper individuals can be notified. Health insurance information is desired when registering although this is an optional feature; discloser of this information is your choice. The section insures that all information collected will remain confidential and privileged to only adult members of the conference management. All youth participants must have an adult present when registering.

Also, prior to registering it is recommended that you preview the <u>Training List</u> of offered courses through Machquigen University and prioritize a list of courses that you wish to take based upon your college of choice. Just a reminder: you must select three courses from the same college in order to receive a degree from that college; if not you may opt to earn a degree in general studies which enables you to select any courses offered through the University. Machquigen University Training is the only activity scheduled for Saturday morning and is required for all participants attending conclave. You will also be asked for an alternative elective which will be used in the event that a course you have chosen if full and closed to participants. For individuals wishing to apply for a Bachelors Degree (meaning you earned an associates degree last year) you must continue taking courses from the same college you attended in 2003, i.e. College of Leadership and Program. You may switch colleges however when you go to petition for a degree you will be opting for an associates degree (Red Border) instead of a bachelors (Blue Border).

Additionally all OA membership information will be required when registering including: OA Honor, OA Chapter, OA Lodge, and OA Induction Date.

1. ACCEPTANCE OF TERMS

Welcome to Sectionmaster©! The section now provides a systematic approach of registration, a new service provided to you, subject to the following Terms and Conditions ("TAC"), which may be updated by us from time to time without notice to you. You can review the most current version of the (TAC) at any time at: <u>http://www.w4b.org/support/terms/</u>. In addition you are responsible when using Sectionmaster© and the online registration to visit the section web-site from time to time for any last minute information pertaining to conclave such as newly implemented guidelines or rules applicable to the event. All such guidelines and rules are hereby incorporated by reference into the TAC.

2. DESCRIPTION OF SERVICE (DOS)

The section has established this system to better serve its members by having a fast and precise registration process for conclave. Features of the system include: registration of training courses (offered through Machquigen University), training certificates, various communication tools, storage of personal and emergency contact information, and conference confirmation forms. Online registration is required by all members attending conclave and failure to register online will result in paying the general conclave fee of \$46.00 dollars.

Similar to the National Order of the Arrow Conference, lodge contingents are formed ahead of time and *all* fees associated with the conference including the names of *all* individuals attending the conference are submitted to the National Order of the Arrow Committee months in advance for review and processing. A section conclave is the second largest event in the nation, that the Order of the Arrow produces annually, and because of this the section has agreed to operate under the same guidelines of registration. You understand that members registering online will not have to pay for the event during the online registration process; instead each lodge that members are affiliated with will reserve a place within their lodge's contingent and agree to pay the conclave fee for you. The guidelines for chapters and lodges getting reimbursed by members that register online are discussed herein.

The Conference Management and Section W-4B Council of Chiefs currently provides members of the Order of the Arrow the opportunity to register for Conclave online. The basis of forming this system was to provide a quick and easy style of registration and to allow members of the Order of the Arrow the opportunity to mark their intent to attend the upcoming Conclave in an organized fashion; furthermore to ensure a fiscally safe environment with regards to the handling of the sections finances.

It is agreed that all lodges will be allotted a contingent based upon the number of members (from their home lodge) that register online before the deadline set forth by the Section Council of Chief's; April 1, 2004. Additionally, you acknowledge that member's attending the event that register after the deadline, April 1, 2004, or do not register at all will be subject to the general conference fee of \$46.00 and the names of these individuals will not be included within your lodge's contingent list; members affected by the deadline will be required to register onsite and bring cash or check made out to "Order of the Arrow - BSA" in the amount of \$46.00; lodges will not accept or collect any fees associated with registration after April 1, 2004. Credit card machines will not be available for use onsite. If you fall within this category and forget to bring your general conference fee with you to the event on Friday, you will be escorted off the premises or your lodge may be billed your conclave fee.

It is understood and accepted that any and all attendees that forget his or her conference fee and does not pay (meaning the section has not received payment) and remain onsite, the lodges will be charged directly for these individuals after the conclave and it will be the responsibility of the lodges and their council professionals to collect their fees; the same applies to all scouting professionals that work for a council within Section W-4B. You also acknowledge that you cannot pay your lodge after the deadline has passed unless you have registered online ahead on time and have a confirmation form dated before April 1, 2004; once more lodges *will not* accept conclave fees past the deadline without your confirmation. You acknowledge and understand that if you or a member of you lodge does indeed pay after the deadline that your name will not appear on the contingent list and in order to avoid getting charged again you must have a receipt verifying your payment.

If you pay but do not register before the deadline has passed, you acknowledge and agree to pay the difference of the general registration fee to the amount you previously paid; the difference in fees will be required prior to check-in and before official admission to the conclave by all individuals that fall within this category.

Once the registration deadline has passed each lodge will receive a personalized printout (at the April section meeting) of members from their lodge that have marked their intent to attend Conclave 2004 and upon previous agreement will be given the remainder of the month to pay for their lodge's Conclave Contingent. Lodges are hereby required to pay (in full amount) for all members listed within their conclave contingent list; payment must be received by the host council, Old Baldy Council, (1) one week prior to Conclave or if this is not possible your check must be hand delivered to the Section Conference Management on Friday upon check-in by your Lodge Chief, Lodge Adviser, or Lodge Staff Adviser. Your Lodge Contingent will not be able to register until your lodge's entire Conclave Contingent has been paid for. We cannot allow lodges to register if your check is "in the mail!"

If your lodge does not pay for every individual that appears on the section roster then your lodge will again be charged the general conference fee of \$46.00 dollars for each Arrowmen (because the fee will be late) that your lodge fails to pay for; even though they pre-registered; even if they do not attend conclave or they previously paid your council the early registration and failed to register online. The only exception will be in the event that an Arrowman has followed the cancellation procedures set forth by the section which are discussed herein. Additionally the section will not allow "swapping" of members, i.e. Johnny Arrowman #1 cannot attend and Johnny Arrowman #2 has agreed to take his place. In this situation the lodges will be able to pickup and be the keeper of these individual's check-in materials, and deliver them at their own discretion.

Any and all excess fees that are included in the check will be deducted and submitted to the Maury Clancy Fund for donation, unless a typed roster is submitted with the check, containing the names of individuals that your lodge is paying for; these fees also must be in increments of \$46.00 per person in order to be accepted.

Members that are serving on the Conference Management, i.e. elected members of the Council of Chiefs and their respected Advisers, as well as honorary guests of the Section Chief may be eligible for exemption from all conclave fees; all individuals qualifying for conclave fee exemption must be approved by the Section Chief and Section Adviser prior to the deadline. Qualifying individuals will be included within your lodge's "Contingent List" and under their "conference fee" it will read exempt; these Arrowmen will not affect the lodge's total fee owed.

You also understand and agree that the *Service* may include advertisements pertaining to the conclave and that these advertisements are necessary for the section to provide and maintain contact with its members. You also understand and agree that the service may include certain communications from the Section Chief or his designee, such as special announcements, administrative messages and section newsletters, and that these communications are considered part of your registration and you will not be able to opt out of receiving them. Unless explicitly stated otherwise, any new features which augment or enhance the current Service, including the release of new Sectionmaster© properties, shall be subject to the TAC. You understand and agree that the Service is provided "AS-IS" and that the Section assumes no responsibility for the timeliness, deletion, mis-delivery or failure to store any user communications or personalization settings; the only proof of registration or existence within the system will be your confirmation page that will appear before you submit your registration; this must accompany you to conclave and the responsibility of this is solely up to you.

You are responsible for fees associated with the event and agree to pay the fee that pertains to you: \$36.00 dollars for early registration and \$46.00 dollars for general registration. Your confirmation form will be dated and disclose the amount you owe. By submitting your form to the section Conference Management you agree and give permission for your lodge to pay for your conclave fee and hereby agree to fully reimburse your lodge immediately. Lodges that contain chapter accounts are hereby granted permission to deduct the necessary funds from each of the chapter's within their lodge and the primary responsibility of the collection of funds will lie in the hands of the individual Chapter Key 3's: Chapter Chief, Chapter Adviser, and Chapter Staff Adviser. Lodges without chapter accounts are responsible for charging its members accordingly and the collection of funds will take place at the lodge level. Your Lodge Staff Adviser will be responsible for the collection of all funds and will be solely responsible for all aspects associated with your lodge at conclave, including your lodge contingent, and your lodge's registration. You also acknowledge that if you register and cannot attend the event do to personal reasons, you must notify the section by sending an e-mail to w4bconclaveregistration@yahoo.com prior to the deadline of April 1, 2004. You also understand that failure to do so will result in not being eligible for reimbursement; additionally you understand that if you do not follow these precise guidelines for registration conference name badge and conference patch. Last minute "matters of emergency" may be eligible for reimbursement and will be dealt with on a person to person basis; all people wishing to challenge the reimbursement of funds must have justifiable proof of a medical emergency of death in the family to qualify; reasons such as a high school dance or SAT testing are not acceptable reasons for reimbursement.

PPPPPP: Prior Proper Planning Prevents Pitiful Poor Performance!

You also understand that if the section has no record of you attending conclave in previous years a new "*permanent*" account will be created for your use. Members that attended conclave in 2003 should have an account; these may be viewed at http://www.w4b.org/sectionmaster/. Members that attended in 2003, however failed to register will not have an account and the section has no record of you ever attending conclave or partaking in Machquigen University training; therefore you will be issued a new account and you will not be eligible to earn a bachelors degree from Machquigen University. All first time participants will also be ineligible to earn a bachelors degree and assuming they attend all four training sessions (three from the same college) at conclave, will qualify for an associate's degree. All members wishing to purchase items in the auction will use their permanent ID number assigned to them at registration.

Please be aware that Sectionmaster© requires a digital consent from your parent or guardian if under the age of 18 and it will be assumed that you have been granted permission and consent to attend the event by your parent or guardian. Adults will sign consent to attend the event for themselves by completing the registration process.

3. YOUR REGISTRATION OBLIGATIONS

In consideration of your use of the Service, you agree to: (a) provide true, accurate, current and complete information about yourself as prompted by the service's registration form. You also acknowledge and give permission to the section to alter your training schedule as deemed necessary in order to satisfy the layout of training courses. The section will keep in mind the back-up courses chosen by the participants in making schedule changes within the University.

If you provide any information that is untrue, inaccurate, not current or incomplete or the section have reasonable grounds to suspect that such information is untrue, inaccurate, not current or incomplete, the Conference Management has the right to suspend or terminate your account and refuse any and all current or future use of the Service.

The Conference Management is also concerned about the safety and privacy of all its users, particularly youth. For this reason, parents of children under the age of 18 who wish to attend must have parental consent to register online and attend the conclave unless one of the members of the immediate family will be attending the event with them. It will be assumed that all registrations forms submitted will have a parental digital consent.

Members not wishing to disclose their health insurance information to the section have that right and may place "Not Disclosed" in the text field. Although we recommend you have this information made available in the event of an emergency, it is at your own discretion.

4. SECTIONMASTER©! PRIVACY POLICY

Registration Data and certain other personal information about you are privileged and confidential. Any and all information collected during the registration process will remain in the hands of Adult members of the Conference Management. These will also only be made available to the Conference Management and all such information will erased from all computers being used at the event after the conclusion of the conclave to insure your privacy; however your information will remain on file and be made available for future use by the Administration Chairman at future conclaves. This is for your protection as a member of Section W-4B, Order of the Arrow.

You acknowledge, consent and agree that the section may access, preserve, and disclose your account information and Content if required to do so by law or in a good faith belief that such access preservation or disclosure is reasonably necessary to: (a) comply with legal process; (b) enforce the TAC; (c) respond to claims that any Content violates the rights of third-parties; (d) respond to your requests for customer service; or (e) protect the rights, property, or personal safety of Sectionmaster© its users and the public.

5. CODE OF CONDUCT

By Submitting your registration you agree to abide to the following rules governing the Conclave:

- You agree to observe the Scout Oath, Scout Law, and the Order of the Arrow Obligation.
- You agree to where your official Boy Scout uniform properly at all times designated by the Section COC.
- You agree to where your name badge at all times.
- You agree to attend all training sessions, conclave activities, shows, and other events. You additionally acknowledge that all such activities pertaining to the conclave will require you to present your ID badge to the staff, including all meals!

- You agree to respect the rules prohibiting the use of private automobiles during the Conclave and will not leave the premises during the event without permission of the Section Chief and Section Adviser.
- You agree to assume personal responsibility for the breakage of or damage to the conference property and assume personal responsibility to the loss of personal items during the conclave.
- You understand that the purchase, possession, or consumption of alcoholic beverages or illicit drugs is expressly forbidden, both youth and adult.
- You agree to obey and follow the Boy Scout's of America policy on smoking (i.e. refrain for smoking in view of youth) and observe all Chaffey High School No Smoking restrictions. (Including the college sections of the property!)
- You understand that gambling or the use of fireworks or firearms is expressly forbidden, and that no fires, lighters, or matches may be used on campus.
- You agree to be a considerate guest of Chaffey High School and a good representative of Section W-4B, the Order of the Arrow, and the Boy Scouts of America.

You acknowledge, agree, and will abide to all *Terms and Conditions* discussed herein.



The following guidelines and judging criteria are to be used by Section Competition Committee. Any dispute with the guidelines will be left up to the discretion of the CVC of Competitions, his adviser, or the Section Chief.

I. CAMPING PROMOTION COMPETITION

Camp promotion competition will be divided into two categories; unit presentation, and static display/presentation. Judging criteria for each category is listed below.

A. Unit Presentation

This category is to judge the presentation that is given to local units when visited by the Order of the Arrow. Topics of discussion should include both local long term and year round camp opportunities.

Appearance (9 points)

Are the presenters in full Class "A" Scout uniform? Did they promote their council camping programs?

Comprehension (9 points)

Did the presenter speak slowly and clearly? Did he make himself understood?

Presentation/Staging (9 points)

Did they use visual aids? Is there identification of the Order of the Arrow?

Resources (9 points)

Do they have current event flyers or an up to date Council calendar? Do they have the Lodge where to go camping guide? Do they have flyers or information about their Council camp programs?

Impression (9 points)

Did the presenters leave you with a better understanding of camping in their council?

Time Limit (5 points)

Was the presentation under 15 minutes?



I. CAMPING PROMOTION COMPETITION

B. Static Display - Presentation

This category is to judge the display/presentation that might be set up at council/civic events by the Order of the Arrow to promote Scout camping.

Appearance (10 points)

Is the display manned? Are they in full Class "A" Scout uniform? Did they promote their council camping programs?

Comprehension (10 points)

Did the presenter speak slowly and clearly? Did he make himself understood? Was he knowledgeable of the topic?

Presentation/Staging (10 points)

Is there a booth or display area? Are there visual aids? Is there identification of the Order of the Arrow? Are there pictures? Is the display well put together with thought and planning?

Resources (10 points)

Are there current event fliers or an up to date Council calendar? Are there copies of the Lodge where to go camping guide? Are there fliers or information about their Council camp programs?

Impression (10 points)

Did the display/presenters leave you with a better understanding of camping in their council?

C. <u>Recognition and Awards</u>

- 1. Awards will be given to the top three teams according to the judges.
- 2. Awards will be presented in both categories and an overall award for combined.
- 3. Combined award will be presented only if a lodge competes in both categories.

D. Judges

Each lodge will be required to provide two judges, one youth and one adult.

II. SPORTS COMPETITIONS

A. <u>Ultimate Frisbee</u>

Overview: The team will consist of six Arrowmen. The games will last fifteen (15) minutes. The team must catch the Frisbee in the designated end zone. Teammate has two steps to slow down only. No steps if standing still. Defending team must give thrower a 1 yard circle. Frisbee in air is fair game to catch/knockdown. Goals count as one (1) point. Intent to injure or harm a player will be a disqualification of a player. This player may not be replaced for this game. A team losses possession if the Frisbee touches the ground, goes out-of-bounds, caught by opposing team, or the player runs with the Frisbee. **The Referee has the final say in all calls.** Overtime is Sudden Death, First Goal Wins!

Materials Needed: Score sheets, ribbons for 1st, 2nd, 3rd place, and participant.

Judges: Two Referees will be needed for this event.

II. SPORTS COMPETITIONS CONTINUED

B. <u>Tug-of-War</u>

Overview: Each lodge will provide five Arrowmen to compete in a tug-of-war competition. They must have the same five compete throughout the competition. We will also be having an adult bracket. The final competition will be held between the youth and adults.

Rounds: Round one - Tiwahe vs. Navajo; Round two - Cahuilla vs. Wiatava The winners from each round will compete in the final round.

Materials Needed: Score sheets, taped off area, and rope. Ribbons for 1st, 2nd, 3rd place, and participant.

Judges: Two Judges will be needed for this event.

C. <u>Soccer</u>

Overview: A team of six Arrowmen will compete in a fifteen-minute game.

Location: <u>Meadow</u>

The Game: The game will last fifteen (15) minutes. There will be no goalies but a player may stand in front of the goal. Substitutions may be made at any time throughout the game. A flagrant foul ejects a person from the games. A team may not replace that player during that game. The goal will be twelve feet wide. A goal must go between the cones and below shoulder length. **The referee has final say on a goal!** Once a goal is scored, the ball is placed at mid-field and a kickoff takes place. Coin toss at the beginning to decide whose ball. **No Cleats will be allowed!!** Overtime is Sudden Death, First Goal Wins!

Materials Needed: Score sheets, ribbons for 1st, 2nd, 3rd and participant.

Judges: Two Referees will be needed for this event.

D. Adventure Race

Overview: Three Arrowmen will compete in a team_event. They will all run together. Each of the arrowmen will do an individual event. The individual events will include swimming, rock climbing, and Archery. The team will also canoe across the lake. First one to complete the layout wins.

The Race: The race will start at the swimming pool. The race will end when the first team has hit the target in the designated location with an arrow.

Materials Needed: Course markers, score sheets, and ribbons for 1st, 2nd, 3rd, and participant.

Judges: One judge from each lodge in order to participate.

Section W4B, Conclave Plan Book, 2004 II. AMERICAN INDIAN DANCE AND SINGING COMPETITION

The following guidelines and judging criteria are in use by the National Order of the Arrow and sections are encouraged to adopt these same guidelines for section conclaves. W4B will be abiding by all national guidelines and criteria for judging of the American Indian Events at the 2004 Section Conclave.

W-4B American Indian Event Guidelines

I. DANCE COMPETITION GUIDELINES

A. Individual Dance Competition

Any number of contestants from a lodge may participate in the Individual Dance Contest. The top dancers may be asked to demonstrate their skills at the evening show. Awards will be received at the Sunday show. The rules are as follows:

1. All contestants must confirm their registration when they arrive at the conclave.

- 2. There will be five categories of individual dance competition:
 - Fancy-Dance (one class)
 - Grass
 - Straight Dance
 - Old Style
 - Traditional (contemporary traditional).

Awards will be given to the top finishing dancers according to the judges' discretion.

3. Dancers must wear appropriate authentic clothing. There are many styles, but they may include as their basic elements: a hair roach, neck and/or back bustles, moccasins, bells, apron (breechclouts), and miscellaneous accessories, such as beaded cuffs, belt, arm bands, choker, headband, etc. War bonnets and chief's clothing are only acceptable for Old Style competition.

In an effort to distinguish between Old Style and Traditional, these categories will be determined by the judging staff. Consideration will be given for bustle type, clout or apron, and quill and beadwork designs. As a general guideline, Old Style is considered as pre-1920. If in doubt as to which category to dance, the dancer should bring a photograph of his dance clothes to registration. The judges will assist in placing the dancer in the proper category.

4. Dancers must dance in the style of their clothing. In preliminary competition, if the dancer is eliminated in one dance style, he may change outfits and dance in another style, if scheduling time permits. The dancer must be registered in both styles. Dancers may not compete in the finals in more than one category.

5. Losing a major article from a dancer's attire during the contest means automatic disqualification. Having the attire properly maintained and tightly secured easily eliminates this problem.

6. All dancers must be younger than 21 and be a registered participant of the event. If a question regarding age arises, proof of age (driver's license, copy of your birth certificate, etc.) must be provided.

I. DANCE COMPETITION GUIDELINES

<u>A. Individual Dance Competition Continued</u>

7. All dancers must be members of the Order of the Arrow and registered conclave participants.

8. Dancers must be prepared to dance indoors or outdoors.

9. Dance practice and outfit construction should not take place during conclave activities.

10. Each participant will be issued a contestant number, which must be visible while dancing in any competition.

11. Overstepping the song may lower a dancer's placement in the overall standing.

12. **NO PARTS OF ANY PROTECTED SPECIES ARE PERMITTED ON ANY OUTFIT.** Violation of this rule will result in automatic disqualification. Please be aware of any federal and state laws regarding endangered species parts. (See Chapter 4, Section Conclave.)

13. Within the guidelines found in the U.S. Code pertaining to the American Flag, flags are not to be used as wearing apparel. With this in mind, no type of U.S. flag(s) will be permitted as part of dance attire. If a dancer has these items on his outfit, they must be removed prior to the conclave. Flag motifs in quillwork and beadwork are acceptable.

14. National Order of the Arrow Face Paint Policy: national Order of the Arrow conferences and activities conducted beyond the individual lodge will not permit face paint, body paint or wigs to be used in social or competition dancing or in ceremonies. (See Chapter 4, Section Conclave.)

15. The Boy Scouts of America policy regarding weapons will be followed. All dancers are encouraged to participate in the judging of American Indian clothing. This judging will be held immediately before or after the dance competition. A panel of selected judges will give out clothing critiques and ribbons.

The judging criteria will be as determined by the judging committee. All judges' decisions are final.

B. Group Dance Competition

1. Group dance teams shall be made up of 4 or more (at least three of whom must be dancers). All team members must be from the same lodge. A team may perform a maximum of two (2) specific group dances. However two dances for presentation are not necessary; it is an option. The judges look for quality rather than quantity. Also, consider that if a single dance is done it should be long enough for the judges to properly evaluate the presentation.

2. The dance(s) must be historical group dance(s) of specific tribes- therefore - northern plains or puebloare not appropriate because they are culture areas, not tribes. Inter-tribal is even less specific. The dance(s) and costuming should represent one particular tribe during a particular time in their history.

3. All team participants must be younger than 21 at the time of the conclave, be registered members of the Order of the Arrow, and registered conclave participants.

4. Team dancing is a coordinated group effort. It is not a series of solos grouped under one title.

5. No preference is given to large or small teams and there is no reason to separate them. The judges look for quality of presentation and the selection of dance(s) suitable to the lodge dance team and the resources available to them.

6. Synchronized line dancing, as done at modern pow-wows is NOT appropriate for historical group dance competition.

Section W4B, Conclave Plan Book, 2004 I. DANCE COMPETITION GUIDELINES

Acceptable Historical Group Dances

In choosing the dance(s) to perform, consider the following:

1. Dances must be **NON-RELIGIOUS** and in good taste.

2. Society, clan, or family dances are acceptable ONLY if written permission is granted by the Tribal Council, society, clan or family of the specific tribe from which the dance comes. **Note: Such typewritten permission must be included in the bound packet required for registration. Therefore, permission must be requested far enough in advance to meet the registration packet deadline. Without permission, the dance will not be allowed.

3. Tribal councils have asked that Scouts refrain from performing the following dances. (THESE DANCES ARE NOT ACCEPTABLE FOR CONCLAVE COMPETITION):

- Masked dances of: Pueblos, Apache, Iroquois, Creek, Cherokee Creek, or Northwest Coast tribes. A mask is defined as anything that covers the face of the wearer, hiding his true identity.
- The Ghost Dance, The Pipe Ceremony, The Pipe Dance, The Sun Dance, The Hopi Snake Dance, and the Peyote Ritual.

4. Dances that are kept so secret that information on them is incomplete should be avoided. The team must have accurate information.

5. **NO PARTS OF ANY PROTECTED SPECIES ARE PERMITTED ON ANY OUTFIT.** Violation of this rule will result in automatic disqualification. Please be aware of any federal and state laws regarding endangered species parts. (See Chapter 4, Section Conclave.)

6. Within the guidelines found in the U.S. Code pertaining to the American Flag, flags are not to be used as wearing apparel. With this in mind, no type of U.S. flag(s) will be permitted as a part of dance attire. If a dancer has these items on his outfit, they must be removed prior to the conclave. Flag motifs in quillwork and beadwork are acceptable.

7. National Order of the Arrow Face Paint Policy: national Order of the Arrow conferences and activities conducted beyond the individual lodge will not permit face paint, body paint or wigs to be used in social or competition dancing or in ceremonies. (See Chapter 4, Section Conclave.)

8. The Boy Scouts of America policy regarding weapons will be followed.

TIME LIMIT Fifteen (15) minutes is the total time permitted on stage. Total time begins with the announcement by a team member. Total time includes prop/scenery set up (if any), narrative, dance(s) plus costume changes (if any), and the removal of any props or scenery.

NOTE: Scenery is not necessary. No score will be reduced for lack of it. Some teams have enhanced their score for general effect and impression with the creative use of scenery produced and moved by other lodge members who want to participate in a different way in the presentation. This is fine; however, if the team does choose to use scenery, keep it simple. Set-up and take down of scenery will reduce team dance time since, as stated above, everything must fit the 15 minute time slot. Without scenery top scores can be earned with excellent dancing, spacing, costuming, and hand props.

NOTE: All team members should be prepared to talk with the judges (if asked) after their presentation.

I. DANCE COMPETITION GUIDELINES

C. Dance Registration

In order for a lodge to participate, the following information must be submitted in advance (late submissions will result in a deduction of scoring points.):

1. A description of the dance(s) as they will be performed.

- 2. The historical background of the dance(s).
- 3. The historical background of the song(s) used in the dance(s).
- 4. A clear description of the props used (include pictures and/or drawings).
- 5. A clear description of the outfits to be worn for the dance(s) (include pictures and/or drawings).

6. A description of the music and accompaniment that will be used (see 3, above).

7. A complete bibliography of references used to research the dance(s), (i.e., books, publications, people).

8. A copy of the letter of permission from the tribal council, society, clan, or family as required for certain dances.

9. Name, address, and phone number of a contact person representing the team.

10. NOTE: Xeroxed pages from any published works are **NOT** acceptable. Due to a lack of VCR equipment, videotapes are **NOT** acceptable.

11. Research booklets should be a minimum of 8 typewritten pages, not to exceed 15 typewritten pages. Photos and drawings/diagrams are not part of this limit.

C. Recognition and Awards

- 1. Awards may be given to the top finishing teams according to the judges' discretion.
- 2. Awards for authenticity may be given if deemed appropriate.
- 3. Certificates may be awarded to each entering team.
- 4. The top team may be given the opportunity to perform at the evening show.

I. DANCE COMPETITION GUIDELINES

D. Judging Criteria For Group Dance Competition

(The following is the criteria the judges will use to score each team entering the Group Dance Competitio)

A. AUTHENTICITY

Teams will be evaluated as to whether the dance(s) performed are acceptable, non-religious dances. The current use of the dance(s) and their proper interpretation by the team will also be considered. MAXIMUM POINTS - 10

B. RESEARCH

Teams will be evaluated on the quality of the research booklet they have done for their particular dance(s). This research should include: book sources, other published sources, people, letters of permission (see Acceptable Historical Group Dances, above), pictures/drawings of outfits, descriptions/diagrams of the actual dance(s). Information and historical background of the dance(s) and songs should also be included. MAXIMUM POINTS - 20

C. AMERICAN INDIAN ATTIRE

Teams will be judged on the authenticity and completeness of the attire. If a particular dance does not call for special attire, teams will be judged on the quality and appropriateness of each participant's attire. In the event of a team performing more than one dance, points will not be subtracted for using the same attire for both dances, if from the same culture area.

MAXIMUM POINTS - 15

D. PERFORMANCE OF DANCE

Teams will be judged on the quality of the interpretation and presentation of their dance(s). Good use of allotted dance time will be considered. Teams will lose one (1) point for every minute that they exceed their scheduled dance time.

MAXIMUM POINTS - 15

E. ABILITY TO PERFORM AS A TEAM

Teams will be judged on their ability to perform their dance(s) so as to exhibit a true oneness and feeling for the dance(s). Teamwork and perceptive interpretation of the dance(s) by the team as a whole will be considered.

MAXIMUM POINTS - 15

F. MUSIC

Teams will be judged on their use of drumming, singing and any other necessary musical accompaniment that should be used for their particular dance(s). As always, quality as well as authenticity of the dance(s) will be considered. The use of recorded music will be allowed, but it will cost the group a significant deduction of points in this judging category. MAXIMUM POINTS - 15

G. GENERAL EFFECT AND IMPRESSION

The overall general effect and impression of the dance(s) will also be considered. MAXIMUM POINTS - 10

H. CONSTRUCTIVE COMMENTS (NOT SCORED)

JUDGING CRITERIA ARE SUBJECT TO THE INTERPRETATION OF THE JUDGING COMMITTEE. All JUDGES' DECISIONS ARE FINAL.

Section W4B, Conclave Plan Book, 2004 II. TEAM SINGING COMPETITION

A. Rules & Guidelines

Singing will be done in team fashion. Teams will be required to sing 2 songs and are required to submit written documentation on the songs with their pre-registration form.

Awards will be given to the top teams. The judging criteria shown below are guidelines that are subject to the interpretation of the judging committee. All judges' decisions are final.

EACH LODGE IS REQUIRED TO BRING ITS OWN DRUM AND DRUMSTICKS.

The following rules apply to the Team Singing Competition:

1. All singing will be done in a team fashion.

2. Written documentation is required for each song (include where the song was obtained, what tribe it's from, etc).

3. Teams will be required to sing a general song and a song for a special event.

4. Songs are restricted to Southern and Northern Plains singing.

5. Teams will be judged on the authenticity and quality of presentation of songs.

6. Anyone singing must be younger than 21, a member of the Order of the Arrow, and a registered conclave participant. All team members must be from the same lodge.

7. Minimum time of 2 minutes, maximum time of 10 minutes for each song.

8. A representative from each team must be present at the team and judges meeting; check schedule for time and location.

III. SAND-PAINTING COMPETITION

A. Rules & Guidelines

- Youth may compete in the youth section of this event and Adults over 21 may compete in the Adult section
- No prior experience of sand painting is involved
- The colored sand will be provided
- You may draw anything, as long as it is not obscene, inappropriate, or against the policies of the BSA.
- No registration is required prior to drawing, just fill out the form and start drawing
- You may not copy or destroy anyone else's artwork
- Modern and Traditional Painting may use only Red, White, Black, and Yellow Sand or a mix of these colors
- Traditional may use only their hands, fingers, and a piece of yarn to paint
- Modern may use other instruments such as ball point pens and rulers
- Traditional may paint only traditional Indian designs
- Modern may paint any design, such as a patch design

Section W4B, Conclave Plan Book, 2004 IV. INDIAN CRAFTS JUDGING

A. Rules & Guidelines

- Only Youth-Made crafts may be entered
- The crafts must be finished 15 minutes before the competition
- You may compete in Headgear (bonnets, roaches, hats), Body Apparal (Leggings, vests, shirts), Bustles, Hand Held Items (Spears, shields, medicine wheels, fans), Miscellaneous Accessories (breastplates, chockers, belts moccasins)
- The items must be brought to the competition table at the Irvine trading post before 11:00 (they may be brought back to the ceremony competitions for competing with prior judge approval)
- You must fill out a card stating the following about your item:
 - What the article is
 - o The date from which the article was produced
 - o The use and history of the article
 - o The research
 - The materials used to make the article

V. JUDGES

A. Requirements to be a Judge

- 1. Each judge must be a member in good standing of the Order of the Arrow and a Lodge within Section W-4B in addition to being a registered delegate at the Section Conclave, or an invited guest of the Section Indian Affairs Coordinator (CVC).
- 2. Each must be at least 21 years of age.
- 3. Must have considerable knowledge and experience with Indian lore.
- 4. Each judge may be asked questions to prove his or her knowledge by the Section Indian Affairs CVC.

B. Competition Judges

An American Indian Events Judging Staff will include one judge from each lodge participating in the event, which will be approved by the Section American Indian Events Coordinator, his adviser, and the Section Chief. The staff will be responsible for judging Group Dance, Individual Dance, Team Sing, Indian Crafts, and Sand painting. All decisions are final!
